Library for making machine-local servers

I've had this idea to make a pet game for the server for a while now, but I haven't gotten around to completing it.

However, in the process of working on my pet game, I wrote some C code that I thought might be useful as a reusable library.

You can use it to run a server that listens on a Unix domain socket, without needing any elevated permissions, allowing you to build servers that other Ctrl-C users can interact with.

Here's the repository for now, still in rough shape, but the DLLs it builds are ready to use AFAICT: https://tildegit.org/gome/localserv

This is taking the "terminal challenge" in a bit of a different direction. It's more of a digital detox or digital minimalism sort of thing, but that is fine.

2023-09-03

As part of the terminal challenge, I've started to use tty1 as my standard terminal instead of using a terminal emulator like `xterm` or `xfce4-terminal`. It is incredibly low latency compared to using a terminal emulator inside X, and feels much more distraction-free. To make things comfortable, I've needed to make a couple adaptations.

Change the terminal font.

\$ sudo dpkg-reconfigure console-setup

I use TerminusBold at 14x28 font size.

Switch capslock and escape.

To switch capslock and escape at the tty level, I use loadkeys which changes how to kernel interprets the keymap. My ~/.Loadkeys file looks like this:

switch Caps_Lock and Escape *without* starting X
keycode 1 = Caps_Lock
keycode 58 = Escape

Ham Radio

Semaphore

Heya ^C!

Like most radio amateurs, I've had some thoughts on how, in the event of disaster, we can get a good amount of information around our community and the countryside - Some kind of event like the bushfires experienced down the Eastern side of Australia in the 'Black Summer' of 2019/20, or as experienced in Greece earlier this year.

I first became interested in amateur radio around the time of the Arab Spring & Hurricane Sandy. Several north-African dictators ordered the internet disconnected. Hurricane Sandy proved that seawater and subterranean phone exchanges were a bad mix. Both of these events, happening at around the same time, had activists and organisers cut off from not only each other, but also news from the outside world.

I remember finding the response by those organisers to be astounding. Routers were being flashed with custom OpenWRT to become ad-hoc mesh networks, and some of these were connected to packet radio. Crucially, and where my amateur radio fascination started, north-African organisers used these radios to connect with other organisers in Italy & Spain, providing links for email exchange. 1200 baud isn't a lot, but it's more than nothing. Organisers in New York were able to simply extend the mesh to neighbourhoods which were still internet connected.

Then along came the 'Black Summer', and my mind started to move back to 2012. How can we manage real time communication in hostile environments, and provide updates about our community? What tools are available to me to do this, considering my limited budget? This is when I decided to become a licenced amateur.

Some of the lessons I took from the 2019/20 season were:

- * Telephone exchanges burn just as well as any other building in a bushfire
- * Fibre-optic can (and will) melt
- * VHF & UHF don't like physical barriers like smoke

- * VHF & UHF repeaters are connected together by the internet
- * We've built our entire communication systems around centralised spoke & node exchanges, with VHF & UHF backups
- * In one region of Victoria during 2019/20 all this infrastructure burned, leaving tens of thousands with no outside communication for some days

VK has many and interesting limitations on what an amateur is able to do with their radio, and one of these limitations is 'no encryption'. Operating a link for regular email isn't allowable, as TLS in VK isn't allowable, making it effectively useless for my thoughts.

The thing I was thinking would most be suited to this work – Gemini – isn't allowable, due to its use of encryption. That leaves us with either HTTP or Gopher. Either are fine, I guess. Here's a vid by VK3FOX, looking at TCP/IP over packet radio [1].

JS8Call is an interesting project, which concerns itself with low-power keyboard-to-keyboard text messaging, which includes relaying. It's used easily on 40m & 80m, making it more robust with smoke & other obstacles, and better for longer range work. This is a presentation by VK3GRK on how it works[2].

This is another vid by VK3F0X, showing BBS on packet radio[3]. I think there's a lot of potential for this technology in times of crisis. I'm thinking that everything except Zork would be good in times of crisis.

And last, but by no means least, there's CW & voice. I use software to 'help' me decode CW (I'm crap at it), and software can be used to make it a kind of keyboard-to-keyboard system, albeit without forward error correction. Sometimes the most simple technology is the most appropriate.

I think my next experiments will be software-aided CW over 80m, and setting up a BBS for use with packet radio – Which may be the most quintessential definition of the 'Smol Net'. What also helps is I'm finding this super fun :)

How Section 230 Ruined the Internet's Reputation

Editor's Note:

This article grossly exceeds what I consider target length for zine submissions. However due to this being the spooky season, and this being effectivly a modern digital horror story? I am giving it a pass in spite of this and politics.

Think for a moment: if someone posts something illegal on a website, be it a video that promotes terrorism or a blog post that teaches someone how to make drugs and illegal substances, should the maintainer of that website be liable to such content?

Section 230 is a law stating that "no provider or user of an interactive computer service shall be treated as the publisher or speaker of any information provided by another information content provider." In simple words, the administrator is NOT liable for his actions. Of course, if the drug dealer were to give drugs to someone else, both would be imprisoned, and if an author of a newspaper wrote slanderous comments about someone, both the author and the newspaper organization could be sued. But why not on the Internet? Why can't I sue the person for posting content that promotes terrorist organizations like ISIS and al-Qaeda to my children if Facebook won't listen to my complaints?

Section 230, being part of the Communications Decency Act (CDA), passed in 1996, was originally designed to "protect the screening of pornographic content", and was enacted as a response to a pair of lawsuits against the bulletin board systems run by Compu-Serve and Prodigy in the early 1990s, that resulted in different interpretations of whether the service providers should be treated as publishers or distributors of content created by their users. Its authors, Representatives Christopher Cox and Ron Wyden, believed interactive computer services should be treated as such as a means to protect the growing Internet at the time.

Upon the law's enactment on February 8th, the 'net had erupted in protest. For the next 48 hours, more than 1,500 websites, including Yahoo! and Netscape, switched to a black background as a warning that the CDA would censor free speech. John Perry Barlow, a member of 'netroots', a decentralized Internet freedom movement, and a cofounder of the Electronic Frontier Foundation (EFF) wrote in a definat e-mail widely circulated by these activists and later republished by Wired, lambasting the law.

"Governemnts of the Industrial Mind, you weary giants of flesh and steel, I come from Cyberspace, the new home of Mind," Barlow wrote. "On behalf of the future, I ask you of the past to leave us alone." He grandly titled his hot take "A Declaration of the Independence of Cyberspace".

Then, opponents filed lawsuits. On June 26, 1997, the US Supreme Court removed most of the CDA, but left Section 230. "In some ways, Section 230 was a kind of sheep in wolf's clothing", says Mike Godwin, a lawyer who had helped lead the fight for the EFF. "It was basically something that was really good for the internet that was couched as something that would create more policing."

An early example of Section 230's effects that had disastrous realworld effects was when Kenneth Zeran, a Seattle real estate agent and victim of the 1995 Oklahoma City bombing, started receiving threatening phone calls. He quickly learned that an anonymous user on AOL was posting his name and phone number alongside ads for fake souvenirs making fun of the tragedy. Zeran tried getting AOL to remove his name and phone number, but was slow to respond. He later sued for negligence. Lawyers for AOL responded by filing a motion to dismiss, invoking Section 230's safe harbor. In March 1997, Judge T.S. Ellis III of the Federal Court of Virginia ruled in favor of AOL. Appeals for the Fourth Circuit upheld that ruling, advancing a strikingly broad interpretation of Section 230. They found that if an Internet company were to be notified that its site was distributing something illegal from a third party - be it defamation or death threats - it would remain immune to civil or criminal liability, even if it continued to knowingly propagate the illicit material.

Critics of this law cite this ruling as ushering in a golden age of online harassment. In the years that followed, individuals who felt stung by the negligence of various Web communities repeatedly filed suit for damages. Again and again, their cases were tossed out. "By the end of 2003, Section 230 appeared to be the kryptonite to any plantiffs who were considering a lawsuit against a website or internet service provider", writes Jeff Kosseff, author of The Twenty-Six Words That Created the Internet. A law that had originally been envisioned as a way to keep clean - or clean enough - instead made it safe for hatemongers, tormentors, and purveyors of misinformation.

Mary Anne Franks, a professor at the University of Miami School of Law, compares the behavior of Internet companies under Section 230 to that of gunmakers under the Protection of Lawful Commerce of Arms Act, a 2005 law that provides extensive liability protection to firearm manufacturers and dealers. She argues that the freedom to self-regulate allows companies to ignore public demands to make their products safer - and "we can now see what the industry has chosen to do with that freedom", she says. "They have not only let a lot of bad stuff happen on their platforms, but they've actually decided to profit off of people's bad behavior."

More recently, as of writing this article, Wyden, the co-author of Section 230, has said that conservatives are misinterpreting the law's intent. Rather than encouraging neutrality, the bill was designed to empower tech companies to proactively remove questionable material from their platforms.

Overtime, Big Tech giants used Section 230 in effort to keep themselves in charge for their endless money supply and to keep their cyber hate machine running clean. Being not liable for user posts is like not being liable for holding agendas for techniques on recuiting terrorists or even screening child porn. In fact, this is what actually happened in Gonzalez v. Google LLC: the Supreme Court tossed out a lawsuit that said social media companies bore responsibility under an anti-terrorism law for a 2017 shooting in an Istanbul nightclub. The case involved Nohemi Gonzalez, a 23-year-old who was one of the 130 people killed in attacks by ISIS in Paris in November 2015. Her family said Alphabet Inc.'s Google, through its algorithm-driven YouTube recommendations aided the assailants in violation of the Antiterrorism Act.

The mantra chanted by Big Tech is that weakening or downright repealing Section 230 would have had disastrous effects, forcing

social media platforms, search engines and online marketplaces to radically reconfigure their businesses to protect themselves, as it would be a downright impossible task to do so, and they can only cease operations because of their corporate and online platform structure.

Former President Donald J. Trump also wanted to repeal Section 230 by filing an Executive Order. In it he wrote:

"In a country that has long cherished the freedom of expression, we cannot allow a limited number of online platforms to hand pick the speech that Americans may access and convey on the internet. This practice is fundamentally un-American and anti-democratic. When large, powerful social media companies censor opinions with which they disagree, they exercise a dangerous power. They cease functioning as passive bulletin boards, and ought to be viewed and treated as content creators."

He also wrote that "online platforms are engaging in selective censorship that is harming our national discourse."

He had written this Executive Order because Twitter had given a warning on his Tweets for 'misleading' information. This is like calling out a random person for disliking pizza, and it is up to the user reading the post if it is 'misinformation' or not.

The early 90s to the late 2000s were a time when the Internet was unfettered: you were allowed say anything you want, without being watched over by big corporations selling you for ads. You did not write a YouTube comment or Reddit post, instead you went on tiny spaces called 'forums' which were regulated by volunteer to paid moderators - many of them were easy-going and removed posts if they didn't seem to abide by the rules - and used the forum just like a non-moderator would do. There was little to no concern about Section 230, and many forums were even hosted outside the US, so different laws would then apply.

Most countries do not even have an exact equivalent of Section 230, and the closest it could get would still have an exception added where they are only held accountable for content that they are aware or have 'actual knowledge' of; this applies in Australia, Japan, and the Philippines.

But after 2010, many of these forums were dying out in favor of social media. Even MySpace, which was run by the innocent Tom Anderson, who had run it out of passion and creativity, was replaced by the soulless lizard Mark Zuckerberg and his Facebook Empire in an attempt to destroy the works of creative Internet nerds of the 90s and 2000s in favor of an unprivate and controlled dystopia that had sucked out the willpower of an entire generation. Facebook's influence had led other sites to catch up to his techniques. YouTube changed its layout in 2012 from that of one that actually provided the video content to you without worries into one that adhered to Facebook's principles of addiction and depression. Twitter changed its layout and functionality from a status feed to a microblog that only limited you to 140 or 280 characters per Tweet. These platforms had an incredible power over the Internet as well as the real world something that would have been laughable in the 2000s - Hana Kimura had committed suicide thanks to online slander protected by Section 230. The Japanese bulletin board site 2channel, known for its criminal background, had the accused Shinji Aoba post on the site threatening to inflict an arson attack on Kyoto Animation's main studio building. Despite 2channel being Japanese-made and for a Japanese audience, the site is hosted in San Francisco, CA and is protected by the aforemetioned law.

Section 230 is the main reason why trolling and cyberbulling online is so rampant. While it had existed since Al Gore had opened the Internet to the rest of America (a period known as "Eternal September"), it had mostly been subject to removal by the USENET server or message board maintaier as it would have been subject to liability.

Repealing Section 230 would change the Internet drastically. Whereas online civility would increase, the ability to run a huge business would also be hindered as they would have to pay more attention to what content they are holding on their services.

This act enjoys support from both Democrats and Republicans: Joe Biden says that Big Tech companies need "to take responsibility for the content they spread" and "we must fundamentally reform Section 230 of the Communications Decency Act, which protects tech companies from legal responsibility for content posted on their sites." Donald

Try scrolling through a YouTube comment section or a Reddit thread and you'll find a lot of slanderous comments posted by people even if their real name was shown. The best thing we can do is wait for the lawmakers to wake up.

Lindsey Graham, a R-SC Senator, stated that "you can't sue these people [Big Tech], you can go to the provider and say 'my child is being bullied, my child losing their mind'", and "they go back three times, the company blows them off, the child kills themselves, and they can't sue because of Section 230."
